Bidding will be conducted through national competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" 5th Edition Revised September 2023 ("Procurement Regulations") and is open to all eligible Bidders as defined in the Procurement Regulations.

The bidding document in English may **be purchased** by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a non-refundable fee of GH¢500.00. The method of payment will be cash or bank draft in the name of the Ministry of Communications and Digitalisation. 6. The document will be sent by courier upon specific written request and payment of an additional non-refundable amount for US\$200.00 for overseas delivery costs or GH¢500.00 for local delivery costs by the bidder.
7. Bids must be delivered to the address below on or before **10:00 a.m. local time on June 4 2024**. Electronic Bidding **will not be permitted**. **Late Bids will be rejected**. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below.
