Bank; the African Development Bank or similar institutions and Multi/bi-lateral Donor's Procurement

- Must have good knowledge of procurement policies and procedures of GoG and Development Co-operation Agencies/Donors especially that of the World Bank, as well as a good knowledge of the institutional, technical, and commercial aspects of procurement
- Demonstrated experience in the use of the World Bank procurement system i.e. Systematic Tracking of Exchanges in Procurement (STEP)
- Must have experience in the preparation of the Project Procurement Strategy for Development (PPSD)
- Must have experience in Procurement planning, processing and contract management in STEP
- Must have experience in Contract management & procurement record keeping.
